Contestants: As a condition of membership in the AHSRA / AJHSRA, each contestant must meet the following requirements:

1. **Finals Ad Book/Sponsorship Sales-** Every contestant must sell a minimum of \$300.00 in ads or sponsorships or a combination thereof.
 - a. Finals Ad Book sales must be mailed to Ad Secretary, _____, by the deadline dates listed below:
 - i. First Deadline: One of the attached forms and a minimum of \$150 in sales are due on Saturday during check-in, at the December Rodeo. If not attending the December rodeo, payments should be mailed prior to the due date.
 - ii. Second Deadline: One of the attached forms and the balance \$150 (or more) in sales are due on Saturday during check-in, at the March Rodeo. If not attending the March rodeo, payments should be mailed prior to the due date.
 - b. Your sales responsibility may be sold through ads, awards, sponsorship, etc.
 - c. There will be a \$100 per rodeo weekend late fee for any deadlines not met. You will not be eligible to rodeo until ad/sponsor sales are met.
 - d. You are responsible for collecting and mailing any ads or sponsorships sold along with either of the forms attached including pictures, business cards, etc. to complete ads which will not be returned. These forms, ad, and sponsorships can be emailed to _____ or mailed to _____.
 - e. You must include the contestant's name and back number on all the checks, ads, and forms to receive credit for the ads sold.
 - f. Complete the State Sponsorship form and/or Finals Ad Book Form with each sale.
2. **Finals Ad Book Sales Sponsor Incentive Program:** Any contestant selling additional ad/sponsor money as indicated below will receive incentive money, stalls, and/or hook ups at State Finals. *Not to be paid out until State Finals.*
 - a. \$1000 in sales-Contestant will receive \$100 and one free finals pass
 - b. \$2000 in sales-Contestant will receive \$200, one free finals pass, one stall, and one hook up
 - c. \$3000 in sales-Contestant will receive \$300, one free finals pass, one stall, and one hook up
 - d. \$4000 in sales-Contestant will receive \$400, one free finals pass, one stall, and one hook up
 - e. \$5000 in sales-Contestant will receive \$500, one free finals pass, one stall, and one hook up

- g. one stall, and one hook up
\$7000 in sales-Contestant will receive \$700, two free finals pass, one hook up, and stalls for each event entered at State Finals
 - h. \$8000 in sales-Contestant will receive \$800, three free finals pass, one hook up, and stalls for each event entered at State Finals
 - i. \$9000 in sales-Contestant will receive \$900, four free finals pass, one hook up, and stalls for each event entered at State Finals
 - j. \$10000 in sales-Contestant will receive \$1500, five free finals pass, one hook up, and stalls for each event entered at State Finals
3. **Drawdown Ticket Sales-** Every contestant must sell a minimum of four (4) drawdown tickets. Each ticket is \$100.00. Drawdown tickets must be mailed to Ad Secretary, _____, by the deadline dates listed below:
- a. First Deadline: Two tickets or a minimum of \$200 in tickets are due Saturday, during check in of December Rodeo. If not attending the December rodeo, payments should be mailed prior to the due date.
 - b. Second Deadline: Two tickets or the balance \$200 (or more) in tickets are due Saturday, during check in of the March Rodeo. If not attending the March rodeo, payments should be mailed prior to the due date.
 - c. Drawdown dinner will be held at Alabama High School Finals with a date to be announced.
4. **Family Work Hours-** Every contestant's family must work a minimum of 15 hours at an AHSRA/ AJHSRA rodeo/function/cutting or other assignment that volunteer help is needed.
- a. The hours are per family not per contestant.
 - b. There will be opportunities for all families to sign up for these hours in and out of the arena, including but not limited to event directors, door entry, concessions, grounds/arena help, committees and event set up.
 - c. Contestants will receive a work hours card in their membership packet. Keep this in your wallet, once you work your hour get it signed, when you have your card filled turn into Nicole Overly. You may pick up more cards as needed from Nicole. Every card you fill will go into a drawing at the end of the year.
 - d. All work hours must be completed by the end of the last regular season rodeo.
 - e. If a family chooses not to work the hours or fails to work the hours, the family must pay \$1000 at finals to be eligible to receive awards at the state finals rodeo

In accordance with the NHSRA rulebook pertaining to contestant qualifications, students who attend a homeschool, private school, religious school or correspondence school are eligible for membership if the school is recognized and approved by the state/province board of education or National Board of Education in the state/province the member is applying for membership.
